

WAIVER OF LIABILITY

IN CONSIDERATION of being allowed to participate in the activities of the Red River Working Dogs DVG Club (hereinafter "RRWD") on the property situated at 4034 FM 2645, Savoy, Texas and owned by Terry and Robin Loreth, and utilizing the premises, facilities and equipment on said property, the undersigned (hereinafter "Participant"), for himself/herself and for all personal representatives, heirs, assigns and next of kin:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE Terry or and/or Robin Loreth, or any of their family members, guests, employees, officers, owners, agents, promoters, operators, representatives and/or other RRWD participants (hereinafter "Releasees") for any loss or damage, whether injury to person or property, or resulting in death, of the undersigned, arising out of or in any way related to any and all activities on said property or related to the activities of the RRWD, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE;
2. HEREBY EXPRESSLY ASSUMES FULL RESPONSIBILITY FOR ANY AND ALL RISKS OF BODILY INJURY, PROPERTY DAMAGE OR DEATH arising out of, related to, or incident to training activities or the use of said property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE;
3. HEREBY ACKNOWLEDGES THAT PARTICIPATION IN RRWD ACTIVITIES MAY BE DANGEROUS and involves the risk of bodily injury, property damage and/or death;
4. Hereby acknowledges the existence of DANGERS AND HAZARDS, KNOWN AND UNKNOWN, HIDDEN AND APPARENT, including but not limited to ranching activities, livestock, bodies of water, wildlife, toxic and hazardous chemicals, fire, and firearm use and EXPRESSLY ASSUMES FULL RESPONSIBILITY FOR ANY AND ALL RISKS CAUSED BY OR ASSOCIATED WITH SUCH RISKS, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE;
5. HEREBY ACKNOWLEDGES THAT RRWD ACTIVITIES AS USED IN THIS AGREEMENT INCLUDES ALL RRWD functions and activities without restriction of any kind, including, but not limited to, dog training activities, mere observation/presence on property, classes, seminars, trials and workshops, meetings, firearms discharge, canine good citizen testing, as well as setting up and taking down facilities for the foregoing activities and travel to and from such activities.
6. A LEGAL GUARDIAN SIGNING BELOW ON BEHALF OF A MINOR CHILD AGREES TO INDEMNIFY AND HOLD HARMLESS the releasees from any claim for injury or damage to such child.
7. AGREES TO INDEMNIFY AND HOLD HARMLESS RELEASEES OF AND FROM ANY AND ALL CLAIMS, DEMANDS, LOSSES, CAUSES OF ACTION, DAMAGES, LAWSUIT, JUDGMENTS, including attorneys fees and costs, caused by Participant or Participant's dogs.
